The Executive Director will lead the organization through its next phase of growth and impact, by executing EarthShare Texas' strategic plan, supervising staff, and driving development efforts. This role requires a hands-on leader who can build relationships, grow programs, and manage internal operations to align with our mission. This role requires frequent interactions, in-person, with staff in the Austin office, and some travel throughout the state to meet with funders, partners, and members.

- Engage the board in fundraising, advocacy, and strategic initiatives.

- Financial acumen, including budgeting and organizational reporting.
- Exceptional interpersonal and communication skills; ability to collaborate across diverse stakeholder groups.

- Knowledge of environmental issues and familiarity with Texas nonprofit organizations working in environmental and conservancy spaces.

- Experience working with boards of directors and engaging in strategic planning processes.
- Familiarity with workplace giving programs or similar fundraising mechanisms.
- Proficiency in data-driven decision-making and program evaluation.

Compensation

EarthShare Texas offers a unique opportunity to lead a respected organization in shaping environmental impact statewide. We value balance, flexibility, and equity, offering generous leave and a collaborative, mission-driven culture. The compensation package, including salary and benefits, includes ten paid holidays, PTO benefits (15 days/year first two years, 20 days/year thereafter),10 days sick leave, three months parental leave, paid health insurance and dental plan, and retirement plan (Simple IRA with up to 3% match). The salary will be between \$95,000 to \$105,000, based on direct, comparable experience.
